# YOUR RESPONSIBILITIES AS A REGISTERED PROMOTER

As a Promoter you MUST have an understanding of the *Combat Sports Act 1987* and *Combat Sports Regulations 2004* and abide by the Permit Conditions put in place by the Combat Sports Commission.

# 21 DAYS PRIOR TO A PROMOTION Complete and lodge Part 2 of the Promotion Permit Application. Provide the list of Officials. If applicable, inform the Commission of any international and/or national title contests on the promotion. If necessary, provide a copy of the rules of the organisation to which the title belongs. If applicable, inform the Commission of any international and/or interstate contestant's arrival details. If applicable, inform the Commission of any proposed Junior v Senior contests. If applicable, inform the Commission of any Contestants with sensory impairments. ONE WEEK PRIOR TO A PROMOTION

Notify the hospital with an emergency department
closest to the promotion venue no less than 5 days
prior to the promotion.
Provide the Commission with a run sheet of your
event, detailing the time of the first bout and the
corners each of the fighters will be fighting from.
All new registrations, certificates of fitness and
serology reports for <b>local Contestants</b> must be
received 5 days prior to the event.

serology reports for international/interstate
Contestants must be received prior to the weigh in.

Ensure International Contestants are scheduled to
arrive in Perth no less than 48 hours prior to the
promotion.
☐ Ensure Interstate Contestants are scheduled to arrive
in Perth no less than <b>24 hours</b> prior to the promotion.
☐ Ensure all Trainers and Seconds are registered with
CSC or able to show proof of registration with anothe
recognised body at the weigh in. Those unable to
show evidence of registration interstate or overseas,
